

## Terms of Reference (ToR)

Security Consultant to review and update ChildFund PNG's existing Security and Procedures Manual to ensure fit for purpose and tailored to ChildFund's operation in PNG.

#### **Introduction & Background**

ChildFund Papua New Guinea is the representative office of ChildFund Australia – an independent international development organisation that works to reduce poverty for children in developing communities.

ChildFund Australia is a member of the ChildFund Alliance – a global network of 12 organisations which assists almost 23 million children and their families in 70 countries. ChildFund Australia is a registered charity, a member of the Australian Council for International Development, and fully accredited by the Department of Foreign Affairs and Trade which manages the Australian Government's overseas aid program.

ChildFund began work in Papua New Guinea in 1994 and works in partnership to create community and systems change which enables vulnerable children and young people, in all their diversity, to assert and realise their rights.

ChildFund PNG operates primarily in the Central and National Capital District, with satellite operations extending to several provinces, including Oro (Northern), Milne Bay, East New Britain, West Sepik, the Highlands region, and the Autonomous Region of Bougainville (AROB).

ChildFund is seeking the services of a qualified security consultant to review and update its existing Security and Procedure Manual to ensure fit for purpose and tailored to ChildFund's operations in PNG. The purpose of this manual and operating procedures is to establish clear protocols and guidelines to enhance the safety and security of personnel, assets, and operations in various provinces and locations where we operate.

## **Objectives**

The primary objectives of this assignment are as follows:

- To conduct a thorough assessment of the CFPNG security risks and vulnerabilities.
- To review and update existing Security and Procedures Manual to ensure fit for purpose and aligned with best practices that are tailored to CFPNG needs in the PNG Context.
- To provide training to relevant personnel on the implementation of security protocols outlined in the manual.
- To ensure the manual complies with CFPNG key policies and aligns with the country relevant legal and regulatory requirements.

## **Scope of Work**

The scope of work for the security consultant includes, but is not limited to, the following:

- Conduct a comprehensive security risk assessment, including an analysis of potential threats and
  vulnerabilities faced by the organisation. This will include a detailed assessment of existing security
  systems, infrastructure, personnel resourcing, and provision of recommendations for mitigating risks
  and enhancing security measures including surveillance and emergency response systems and
  mechanisms.
- With the above in mind, review and update the Security and Procedure Manual to ensure identified risks are appropriately mitigated.
- Conduct training sessions for relevant personnel on the implementation of security protocols outlined in the manual. Consideration of frequency of training and update/review of manual.
- Appropriate consideration in protocols around operating model where staff members are in isolated locations without a CFPNG office presence.



- Ensure the manual complies with relevant legal and regulatory requirements, including international standards for development organisations.
- Review and update safety and security briefing and orientation guidelines for visitors and new international staff in line with the overall CFPNG security manual.

#### **Child Safeguarding:**

If the consultant will be having direct contact with children or having access to children's personal information, a Criminal Background Check must also be carried out.

The successful applicant will be required to comply with ChildFund PSEAH policy and sign the ChildFund Code of Conduct.
